TERMS AND CONDITIONS

- 1. All pages of bidding documents are mandatory to be signed / stamped, meaning thereby bidder agrees to our terms & conditions mentioned herein, failing which the bid may be rejected.
- 2. Any addition, deletion or modification of any clause of the procurement terms &conditions/BoQs of CUI, Wah Campus by any vendor will not be acceptable and may lead to rejection of the bid.
- 3. Only registered Suppliers, who are on Active Taxpayers List (ATL) of FBR, are eligible to participate in tender.
- **4.** The contract will be executed and handed over in satisfactory conditions up to the entire satisfaction of COMSATS University Islamabad, Wah Campus.
- 5. Documents along with Pay Order / Demand Draft amounting to **Rs. 1.000/-** as a tender documents fee (Non-Refundable) shall be submitted in favor of COMSATS University Islamabad, Wah Campus to the address given below. No bid will be accepted without tender documents' fee.
- 6. The supplier is well established firm/company in the business of Food/Catering & Event Management with sound financial status.
- 7. Part / Advance payments is not allowed.
- 8. The exact date of Event is 01 Days (09 June 2022). Setup should be ready uptill 04:00 Pm on 08 June. The handing over / completion time for this contract is of critical importance.
- **9.** Your bid proposal should be inclusive of freight and all other taxes and to be delivered at CUI, Wah Campus's premises.
- 10. After opening of bids, CUI, Wah Campus will examine the bids for completeness as per tender document.
- 11. Purchase / Work order (s) will be awarded to the lowest or technically recommended bidder (s) on the basis of item wise / subtotal wise / grand total wise according to the nature of BoQs.
- 12. The bid should be submitted in a sealed envelope up to <u>06 June</u>. 2022 on or before <u>1100hrs</u> and will be opened on the same date <u>at 1130hrs</u> in the presence of available bidders.
- 13. The envelope should be marked as under;

- 14. The envelope shall also bear the word "CONFIDENTIAL" and following identification quotation of <u>"Food</u> & Catering Arrangements for Open house & Job Fair SP-22".
- 15. The bid form (BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder.
- 16. If the vendor fails to deliver the goods / services to CUI-Wah Campus in time then the penalty will be charged as under:
 - a. 1% per day of the invoice price for 5 working days.
 - b. 2% per day of the invoice price for further 5 working days.
 - c. If the vendor fails to deliver the goods / services during the extended period then the purchase / work order may be cancelled, earnest money and payment may be forfeited.
- 17. If the delivered goods / services are not according to the required quality standards / specifications, the same shall be liable to be rejected after inspection. The vendor would be required to supply as per requirements mentioned in our BoQs, otherwise the purchase / work order will be cancelled after due date with confiscation of earnest money.
- 18. Deduction of Income Tax and any other tax will be deducted at source according to Government prevailing rules.
- 19. Payment will be made on submission of Invoice in the name of "COMSATS University Islamabad, Wah Campus" with a copy of delivery challan (s) after the complete order has been supplied, inspected and accepted which includes delivery / installation, and COMSATS acceptance / inspection thereof.
- 20. All prices should be quoted on F.O.R (Pak Rupees) inclusive of all taxes.
- 21. All prices should be valid for at least 30 days. Withdrawal or any modification of the original offer within the validity period shall entitle CUI-Wah Campus to forfeit the earnest money in favor of the CUI-Wah Campus and / or put a ban on such vendor participation in CUI tenders / works.
- 22. It is the sole responsibility of the agent / supplier / manufacturer to comply with the applicable laws, be national or international.
- 23. In case of any dispute or grievance, the matter shall be addressed as per PPRA rules.
- **24.** The CUI-Wah Campus reserves the right to modify the quantities of goods / services at any time before the award of purchase / work order.
- 25. The bidder is required to furnish in form of Bank deposit/ CDR / Pay order equivalent to 2% of the total Bid price as Earnest Money crossed in favor of "COMSATS University Islamabad, Wah Campus".
- 26. COMSATS University Islamabad, Wah Campus reserves the rights reject the bid if;
 - i. Received without earnest money
 - ii. Received later than the date and time fixed for tender submission
 - iii. The tender is unsigned/unstamped
 - iv. The offer is ambiguous
 - v. The offer is conditional
 - vi. The offer is from a firm, which is black listed by any Govt. Office.
 - vii. The offer is received by telephone/telex/fax/telegram.
 - viii. Any unsigned / ambiguous erasing, cutting / overwriting etc. is made.

- **27.** The bidder should furnish a certificate as worded below in token of acceptance of all the terms and conditions of the tender otherwise the tender will not be considered under any circumstances.
